



Privacy policy

Your privacy is very important for **RED LINE SRL**; to better protect it, we would like to provide you with these notes, in which you will find an indication of the type of information that is collected online and on the various ways in which you may intervene in the collection and use of such information on the site. This information notice is provided also pursuant to art. 13 of “Regulation (EU) 2016/679” (hereinafter “GDPR”) to the persons who interact with the Web services of **RED LINE SRL**, accessible via data transmission from the address: <http://www.redline-srl.it/> which corresponds to the home page of the official site of **RED LINE SRL**.

The information notice is only provided for the website of RED LINE SRL and not for other Websites that the user may consult via links.

The Data Controller

The consultation of this website may lead to the processing of data related to identified or identifiable persons.

Types of data undergoing processing

The IT systems and software procedures used for the functioning of this Website acquire, during their normal operation, certain personal data, the transmission of which is implicit in the use of Internet communication protocols.

This information is not collected to be associated to identified data subjects, but, by its very nature may, through the treatment of and association with data held by third parties, allow the identification of the users.

This data category includes **the IP addresses** or domain names of the computers used by the users who connect to the website, addresses in URI (Uniform Resource Identifier) notation of the requested resources, the time of the request, the method used for the submission of the request to the server, the size of the file obtained in reply, **the numerical code that indicates the state of the reply given by the server** (success, error, etc.) and other parameters related to the user’s operating system and IT environment.

These data are used solely to obtain anonymous statistical information on the use of the website and to control that it functions correctly.

The data may be used for ascertaining liability in case of hypothetical computer crimes against the website, exclusively on request of the competent supervisory authorities.

The optional, explicit and voluntary sending of e-mail to the addresses indicated in this website results in the subsequent acquisition of the sender's address, necessary for us to reply to requests, and of any other personal data entered in the message. Specific brief information notices will progressively be provided or displayed on the pages of the website relating to the provision of specific services on request, such as the subscription to a newsletter or the insertion of work applications.

We do not use cookies for the transmission of personal information, nor do we use so-called persistent cookies of any type or systems to track users. The use of so-called session cookies (that are not stored permanently on the user's computer and that disappear when the browser is shut down) is strictly limited to the transmission of session identifiers (made up of random numbers generated by the server) necessary for the secure and efficient exploration of the website.

The so-called session cookies used in this website prevent recourse to other IT techniques that may compromise the confidentiality of the users' navigation and do not allow us to acquire personal data identifying the user. For more information, please refer to the specific cookies policy.

Optional nature of the provision of data

Aside from what has been specified for navigation data, **the user is free to provide the personal data mentioned in the request forms** to RED LINE SRL or otherwise indicated in contacts to request informational material or other communications. Failure to provide them may make it impossible to obtain what has been requested.

Methods of processing

The personal data you provide shall form the object of processing operations in compliance with the aforementioned regulatory framework and the confidentiality obligations that pervade the Controller's activity. The data will be processed both with IT tools and on paper and any other type of appropriate medium, in compliance with the adequate security measures laid down by art. 5 para. 1 letter F of the GDPR.

Transfer of data abroad: The data collected shall not be transferred abroad.

Retention period: The collected data will be retained for no longer than is necessary for the attainment of the purposes for which they are processed ("storage limitation principle", art. 5 of the GDPR) or in accordance with the deadlines set forth by legal provisions. The obsolescence of the data held in relation to the purposes for which they were collected shall be checked periodically.

Rights of the data subjects

Data subjects shall always have the right to request from the Controller access to their data, the rectification or erasure thereof, the limitation of the processing or the possibility to object to the processing, to request the portability of the data, to withdraw consent to the processing by exercising these and other rights laid down by the GDPR via a simple communication to the Controller. Data subjects may also lodge a complaint with a supervisory authority.
